



# Did You Know?

## Parents *already* have rights!

Komrosky claims to “defend” parent rights yet **he hasn’t passed one policy that has been implemented** via an administrative regulation (AR) at TVUSD.

The **so-called “parental notification” policy** (copied word for word from another school district and found unconstitutional by a San Bernardino judge) **is redundant and unnecessary** at TVUSD where parents have more rights than they know!

**Temecula parents (and community members) have the right to:**

- **examine public school curriculum** being taught and observe their child’s classroom at any time with prior notice. California Education Code 49091.10, 1998.
- **ask for an alternative to assigned instructional material** for their student. TVUSD Administrative Regulation 1312.2, January 2018
- **excuse their public-school student** from all or any part of the **comprehensive sexual health education (CSE)** and HIV prevention education required by the California Healthy Youth Act. California Education Code 51938, 2016.
- **gain immediate online access** to their public-school **student’s course materials**, assignments, work, and grades, and the ability to email the teacher. TVUSD Infinite Campus: English and Spanish parent and student portals.
- **be informed about any psychological testing the public school does** involving their child and to **deny permission to give the test**. California Education Code 51101, 1999.
- **examine their child’s public-school records** and **challenge any incorrect information** at any time. California Education Code 56504, 1980.
- **review all proposed new curriculum and provide feedback**. California Education Code 60002, 1996. The new curriculum adoption process follows state guidelines to include teacher direction, classroom pilots, and parental input. TVUSD Administrative Regulation 6141, November 2022.
- **get public school news emailed to them** via the TVUSD Community Connection email newsletter. The subscription link is at the bottom of each edition.

Additionally, **medical and/or mental health treatment is not provided to students without parental consent**. Temecula public school health offices cannot give any medicine to students without written parental consent and written information from a doctor. Education Code 49423 (b)(1), TVUSD Policy 6164.2: Guidance/Counseling Service.

**Parents have many rights in the Temecula Valley Public School District, these are just a few. They are detailed in TVUSD’s annual Notice to Parents, (English and Spanish versions).**

**The Truth: Komrosky is working to remove the rights of parents to make decisions on their children’s education. Vote Yes on June 4.**

How Much?	For What?	What Happened?
\$481,300	Firing/hiring Superintendent	Fired and bought out McClay's contract, hired firm to find new superintendent, and hired a vastly less experienced superintendent.
\$183,600	Legal Fees Incurred by Board Members	Includes only charges for trustees' consultations with attorneys. Does not include any lawsuit costs. <b>In 2022 this figure was \$0.</b>
\$47,900	Extra security at board meetings	Sheriff's Deputies & private personal search firm. Does not include costs for additional district security personnel.
\$30,000	Hiring public relations firm	No-bid contract. The district did not have a PR firm in 2022 and already has a Public Information Officer.
\$28,600 +	CRT workshops for teachers and the community	Includes fees for consultant and panel, substitute teachers' salaries, and Sheriff's Deputies.
\$8,000	5G wireless tower testing	Testing proved Komrosky's theory wrong; no danger present. which every expert told him before he authorized testing.
<b>\$779,400</b>	<b>Total for 2023 extra costs due to Komrosky's policies, not counting lawsuit costs which are still being incurred daily.</b>
